

Thundersley Primary School



The school will

- Provide an environment which has been risk assessed in response to the Covid-19 virus and the following protective measures are in place:
 - the availability of soap and hot water for washing of hands
 - the location and use of hand sanitiser stations
 - the location and use of lidded bins for the disposal of tissues and any other waste
 - a plentiful supply of disposable tissues to implement the 'catch it, bin it, kill it' approach in each classroom
 - Class bubbles that will be isolated from other groups of children as far as possible while they are in school.
- Adhere to social distancing rules as set out by the government as much as we reasonably can
- Provide a curriculum which meets the needs of your child's well-being, mental health and academic needs

- Contact parents/carers if their child displays symptoms of Covid-19
- Inform parents if a staff member or child in their child's 'bubble' tests positive for Covid-19, as this will mean that all members of the bubble will need to self-isolate for at least 14 days
- Continue our clear and consistent approach to rewards and sanctions for children as set out in our Behaviour Policy (updated for Summer 2020) as well as the expectations set out in this document.
- Uphold our safeguarding policy
- Inform parents/carers of developments or changes in provision in as timely a way as possible

Parents / Carers will

- Inform the school if their child, or anyone in my household, shows symptoms of COVID-19,
- Not send their child to school, and self-isolate for 14 days as a family,
- Have our child/family tested and will let the school know as soon as possible via telephone/email
- Collect my child from school immediately, if my child shows symptoms of COVID-19 at school.

- Strictly adhere to the school timings for my child and 2 metre social distancing rules, when dropping off and picking up
- Ensure that my child does not bring any items into school with them or take items home from school other than those specified in this agreement
- Remind my child about social distancing rules
- Remind my child about good respiratory and hand hygiene;
- Recognise that parents/carers will not be allowed into the school without a pre- arranged appointment - make appointments via telephone or email;
- Read all letters/messages/emails that are sent home:
- Inform the school immediately of any changes to parents/carer and emergency contacts details.
- Recognise that, if my child's behaviour is deemed unsafe, that he/she will be sent home and cannot return to school until they can behave safely.
- Adhere to government guidance about social distancing and mixing outside of school.

Children will

- Adhere to the social distancing rules in class and in the playground;
- Tell an adult immediately if they feel unwell:
- Only bring to school the items which they are allowed to and nothing else.
- Only use the equipment provided by school and no other:
- Not share any equipment in school
- Stay within my bubble and not mix outside of it
- Only enter and exit the school building from the designated gate and door
- Follow good respiratory hygiene: coughing and sneezing into elbow or tissue (catch it-bin it-kill it);
- Follow good hand hygiene use soap and water for 20 seconds/ hand sanitiser;
- Follow the guidelines for positive behaviour

Golden Rules

- We stay safe and look after each other, we wash our hands often for 20s and stay 2m apart at all times
- We are kind and respectful, we don't hurt anybody, including their feelings
- We are honest, we don't cover up the truth
- We work hard, we don't waste our own or other's time
